In our capacity as Members of the European Parliament, we would request the pleasure of your company at an online discussion with fellow MEPs (please see list of colleagues co-hosting this event below) and EC Cabinet members on the soon-to- be- adopted Article 17 Guidanceⁱⁱ.

There is quite some concern amongst current and former MEPs involved in this matterⁱⁱⁱ that the current approach to the Guidance would not properly reflect the agreement hardly achieved after long negotiations on Article 17 of the Copyright Directive. The latest response to Parliamentary questions on this matter by the Commission^{iv} and recent public remarks made by members of DG Connect services have not helped to assuage these concerns.

MEPs have seen these concerns mirrored by no less than seven Member States^v that believe the approach set out *exceeds the purpose of the guidelines to be adopted by the Commission and raises very serious issues*. For this reason, we would also like to open this discussion to the above, so that the views of both co-legislators can be expressed.

We also understand that stakeholders across all the major creative and cultural sectors are equally worried about the direction of travel to date^{vi}.

The issues raised in the referenced texts remain a source of open question for Members of the Parliament. The final process leading to the adoption of the Guidance should allow a proper exchange to address them. Further, we welcome an exchange with cabinet members covering the broad implications at stake, which are important in our examination of flagship digital dossiers that impact Europe's economy, jobs, cultural diversity, and media pluralism.
